During the past 35-plus years, Hillel's practice has largely consisted of insurance and appellate work (much of that being outside the area of insurance law). He has also provided opinions on various other issues of law. He has been involved in approximately 150 appeals to the Court of Appeal for Ontario, where he has personally argued approximately 80 to 90 of them.

In 1986, Hillel was certified by the Law Society as a specialist in civil litigation, and has since acted as counsel at trials, both jury and non-jury, on numerous occasions.

Hillel assisted a leading insurance co., servicing municipalities, in drafting and revising language for their municipal liability and E&O policies. As well, he drafted a liability policy for another prominent insurance company almost from scratch. While at McCague Borlack, he has either written or revised policy language for several other insurer clients.

Hillel's work has involved a large number of insurance coverage issues, including third party liability and first party property. He has provided opinions both to insurers and insureds, and has argued numerous insurance-related matters in court. Many of the cases argued are unreported.
