In pursuit of this strategy, McCague Borlack LLP opened its first office outside the GTA in the fall of 2012. This office is centrally located in the Sun Life Financial Centre in downtown Ottawa. Martin Smith is the Managing Partner of this office in the Nation's Capital, which is on the shores of the Rideau River in Eastern Ontario. Since 2012, our Ottawa office has grown to include five (5) Partners and nine (9) Associates, together with several Students and Law Clerks, and full Support Staff. Today, McCague Borlack LLP offers one of the largest and most experienced teams of civil litigators focused on meeting and exceeding our clients' expectations.

THIS EASTERN ONTARIO OFFICE COVERS OTTAWA TO CORNWALL TO THE EAST, SOUTHWEST TO COBOURG, WEST TO PETERBOROUGH, AND UP BEYOND NORTH BAY, TIMMINS, & HAILEYBURY.

In addition, the bilingual Lawyers in our Ottawa office manage files in the Province of Quebec, and serve our clients' needs in the neighbouring City of Gatineau and beyond throughout Eastern Quebec.

KITCHENER

McCague Borlack LLP opened our second regional office in the fall of 2014. The purpose of this office is to serve our clients' insurance litigation and risk management needs throughout Central West Ontario.

THIS OFFICE COVERS FROM HAMILTON NORTH THROUGH BRAMPTON TO OWEN SOUND, ALONG THE SHORES OF LAKE HURON TO GODERICH, SOUTH THROUGH STRATFORD, WOODSTOCK AND SIMCOE TO THE LAKE ERIE'S NORTH SHORE AND THROUGHOUT THE NIAGARA REGION, WITH THE HEAVILY POPULATED TRICITIES OF KITCHENER-WATERLOO-CAMBRIDGE AT ITS CORE.

To facilitate this coverage, our office is located in the Sun Life Financial Building in the heart of downtown Kitchener adjacent to the Ontario Superior Court of Justice (Central South Region). And most recently, in 2019, McCague Borlack LLP opened our fourth regional office in the heart of Southwestern Ontario in the City of London.



TORONTO – HEAD OFFICE


